

TERMS AND CONDITIONS TO REGISTER FOR SPORTS SUMMIT ARGENTINA 2024

NOVEMBER 12-13, BUENOS AIRES, ARGENTINA

1. Introduction and purpose

1.1. These Contracting and Privacy Conditions (hereinafter "the Contracting Conditions") regulate the purchase and sale of the accreditation to attend the Sports Summit Argentina 2024, an international meeting between professionals in the sports industry that will be held in person in Buenos Aires, Argentina and also virtually online, on November 12th and 13th, 2024. Full information about the Event can be found on the website <https://www.sportssummitleaders.com.ar/> (the "Website").

1.2. The entity responsible for the contractual offer is FARLUX INTERNATIONAL SA, registered in the RUT under number 215041850018, with headquarters at Paraguay 2141, office 401, Montevideo, Uruguay (the "Organizer").

1.3. The attendee is the person who duly registers for the Event (hereinafter referred to as the "User"). They must be over eighteen (18) years of age, and have full capacity to act to enter into binding contracts.

1.4. The acceptance of these Conditions of Contract is a necessary condition to carry out the accreditation in the Event. In any case, the possession by the User of an accreditation for the Event automatically implies the assumption of these Conditions of Contract.

2. Characteristics

2.1. The accreditation only gives the User access to the general activities scheduled in the Event, it does not allow them to participate in other complementary activities for which a specific accreditation is required.

3. Accreditation conditions

3.1. Accreditation for the Event can be done online until the following deadlines: accreditation for the Event until November 13th, 2024, or until full capacity is reached. Accreditations must be done through the Website until the closing date.

3.2 The accreditation process in the Event through the Website is carried out through the following steps:

- Completion of the Accreditation Form.
- Once the Accreditation Form has been completed, the user must accept these Conditions of Contract in order to continue the process.
 - Once the Accreditation Contract Conditions are accepted, the system will redirect the user to the PAYPAL payment Gateway or other service provider informed by Organizer, where payment can be made with a card. In the absence of PAYPAL, it will be possible to pay by bank transfer to the Organizer's account number that will be provided by email to the User who requests it through info@sportssummit.org.
- Once the payment is accepted, the User will receive an email confirming their accreditation to the Event. In the case of payment by bank transfer, the User must

send proof of the transfer made to the email info@sportssummit.org and, once the transfer is received, they will receive an email confirming their accreditation in the Event.

- The badge for access to the Event ("Badge") will be collected on the day of arrival at the In-Person Event at the accreditation desk, for which the User must provide the email confirmation of payment of the accreditation and official document that allow their personal identification (CI, DNI, passport, etc.).

3.3. At the User's written request, the Organizer will send the User, to the email address provided by the latter in the Accreditation Form, the electronic document accrediting the execution of these Conditions of Contract.

3.4. Press professionals (journalists/photographers) who wish to cover the Event may register online until November 10, 2024 or until full capacity is reached, being possible to request them via email through info@sportssummit.org exceptionally when this period has ended. The accreditation of press professionals is reserved for press professionals, who must accredit the Organizer through a document that certifies that they work or collaborate in a media outlet and their specialization in the sports industry (for example, a copy of their valid press card, letter signed by the director with the seal and data of the company or platform, in the case of professionals who carry out their activity as freelancers specialized in the sports industry, providing graphic proof of a journalistic work signed by the interested party (text/ images) of recent publication, or any other at the discretion of the Organizer). These professionals once confirmed its certification will not have to pay the price of the Accreditation. The Organizer reserves the right to reject accreditation requests from those applicants who do not sufficiently prove their status as press professionals or when the number of accredited attendees in this field exceeds what is reasonably admissible based on the number of accredited attendees. Once the application is received, the granting of the Accreditation will be confirmed by email, which the accredited professional can pick up at the accreditation desk at the event, for which the professional must provide the email confirming their accreditation and an official document that allows for their personal identification (press card, ID, DNI, passport, etc.).

Press accreditations must be requested prior to the Event taking place by the deadline mentioned at the prior item. During the Face-to-face Event, accreditations will not be processed and exclusively the demands of the general media for daily information (press, radio and TV) that imply the displacement of technical means (mobile units, graphic equipment, etc.) will be tended to.

The press Accreditation will give those accredited access to all the activities at the Event except the scheduled networking activities (for example, one-to-one meetings, speed dating, etc.).

3.5 The Badge is strictly personal and non-transferable. Whoever accesses the On-site Event with a Badge that does not belong to them will be expelled from the On-site Event and from the facilities where it is held, and said Badge will be withdrawn and annulled.

3.6. The User must show the Badge each time it is required.

3.7. The loss or theft of a Badge must be immediately reported by the affected User at the accreditation desk, in which case it will be replaced by another one, after verification by the Organizer of the User's identity (by presenting ID, ID, passport, etc.) and payment for the accreditation.

4. Prices and Form of Payment

4.1. The accreditation prices are published on the Website. Unless expressly indicated otherwise, said prices do not include VAT, provided that this tax is applicable.

4.2. The Organizer may unilaterally review and modify the prices that appear on the Website.

In any case, before proceeding with the payment, the User will be informed of the final price of the accreditation, which will coincide with the information provided at that time on the Website.

4.3. Payment will be made by credit or debit card through PAYPAL or other service informed by the Organizer. To pay, the User will be redirected to the PAYPAL payment gateway, where they must provide their credit or debit card information to make the payment.

4.4. The charges will be made on the bank card at the time of accreditation, which will be confirmed when the payment is confirmed. In the event that the charge can't go through for any reason, the accreditation will not be confirmed.

4.5. To access the Event, and where appropriate, the complementary activities, the User must present their Badge.

4.6. If the User requires an invoice, they must request it by sending an e-mail to the email address indicated in section 1.2 of these Contract Conditions or download it from his accredited profile.

5. Policy for changes and cancellation of accreditations and cancellation of the Event

5.1. Changes and cancellations of the Event: The User may request changes regarding their accreditation for the Event (eg change in the person of the same company that will attend the Event), by means of an e-mail addressed to the email indicated in section 1.2, until November 10, 2024, except in complimentary tickets. The Organizer reserves the right to accept or deny such changes. In the event that the requested change is accepted, the Organizer will send an email to the User confirming the change made. Any change request received after November 10, 2024 will not be honored or accepted.

5.2. The Organizer will only accept cancellation of accreditations for the Event when the cancellation request is received by the Organizer in writing, to the email address indicated in section 1.2 of these Contract Conditions, before November 10, 2024. In this case, the User will be reimbursed 50% of the amount paid for their accreditation, by bank transfer, within a maximum period of 30 days from the end of the Event.

Cancellation of accreditations for the Event will not be accepted nor will payment refunds for accreditations be made, whatever the cause, as of November 12, 2024.

5.3. Event Changes: the User may request changes regarding their accreditation by sending an email to the email indicated in section 1.2, until November 10, 2024. The Organizer reserves the right to accept or deny such changes. In the event that the requested change is accepted, the Organizer will send an email to the User confirming the change made. Any change request received after November 10, 2024 will not be honored.

5.4. The organizer reserves the right to deny entry or to expel, temporarily or permanently, any User whose conduct or behavior affects the peace and security of the Event, other Users, other participants in the Event, workers or the Organizer of the Event, or the integrity of the venue or facilities for holding the Event. In such case, the User will be reimbursed the price paid for their accreditation in proportion to the time remaining from the expulsion until the end of the Event.

5.6 If the Event is canceled, the Organizer will refund the User the amount paid for the accreditation in the shortest possible time and in any case within a maximum period of 30 days from the communication of the cancellation of the Event.

6. Customer service

6.1. The User may ask any question regarding their accreditation to the Event by sending an email to the address listed in section 1.2.

7. Protection of personal data and image rights

7.1. The data provided by the Users through the Accreditation Form (being mandatory to complete the fields marked with an asterisk), as well as those obtained on the occasion of other activities carried out in or in relation to the Event, will be treated under the responsibility of SPORTS SUMMIT.

7.2. The purpose of collecting and processing data is to manage the accreditations, attendance and participation of the User in the Event, both Online and In-Person, its feature in the Industry Guide, as well as to send the User information, promotions and publicity and other types of commercial communications, related or not to the Event, and newsletters of the Event and of SPORTS SUMMIT, and collaborators and sponsors of the Event belonging to the sports industry, update the Organizer's records, display and manage content and communications with the User, respond to communications made by the User and to comply with any legal requirements and will be processed by SPORTS SUMMIT to the extent necessary to satisfy those needs. The User authorizes SPORTS SUMMIT to keep their data and treat them for the purposes described above for the following editions of SPORTS SUMMIT to be held (except to manage the accreditations, attendance and participation of the User and their inclusion in the Industry Guide of such future editions).

7.3. The data of the credit or debit card that the User uses to pay for their accreditation will be provided directly to PAYPAL, the Organizer not having access to said information.

7.5. The User guarantees that the data provided is correct, agreeing to notify the Organizer of any changes that may occur in them. In the event that the User provides the required data in an incomplete or inaccurate manner, the Organizer does not guarantee the accreditation, and the User is solely responsible for the consequences derived from the inaccuracy of the data provided.

7.6. The Organizer guarantees the confidentiality of the personal data provided by the Users, as established in Law 18,331 on the Protection of Personal Data and on Services of the Information Society and Electronic Commerce except for the provisions of section 7.1 in relation with its publication in the Industry Guide.

7.7. The Organizer informs the User that their identification and contact information provided for accreditation may be communicated to the collaborating entities in the Event and to those supplier companies that manage access and/or provide services within the framework of the Event related to attendance and participation of Users in

the Event, including travel and accommodation, solely for the purpose of facilitating said management and provision of services.

7.8. The User may contact the Organizer in order to freely exercise their rights of access, rectification, deletion and, where appropriate, opposition, portability and limitation of treatment. To do so, they must send the Organizer, by certified mail, to the address Paraguay 2141, office 401, Montevideo, Uruguay, or to the email address info@sportssummit.org, a written requirement specifying the right that they wish to exercise, attaching a copy of the official document that identifies them. The provisions of this paragraph do not apply to the provisions in relation to the Industry Guide, for which the provisions of the previous section 7.1 will apply. In any case, SPORTS SUMMIT may keep a copy with the data duly blocked, while responsibilities may arise from the execution of this contract.

7.9. Participation in the Virtual Event will automatically imply acceptance by the User of the Conditions of Use, Privacy Policy and Cookies of the SPORTS SUMMIT Website, which can be consulted in the "Privacy and Cookies Policy" section of the Website.

7.10. The User authorizes the Organizer to take audiovisual and photographic images of the different Event activities in which the User may participate, including Virtual Event activities, such as participation in videoconferences, presentations, panels, etc., as well as the environment of the different forums where the Event is held, images that may include in an accessory or prominent way the User's own image, and likewise authorizes the Organizer to use said images for publication as Event content, in the media in which it is published and promote the celebration of the Event, such as, but not limited to, its website, its social media and newsletters.

8. Exclusion of Liability

8.1. The Organizer declines any type of responsibility that could be derived from incorrect use by the User of the online purchase procedure.

8.2. Any responsibility is also declined for possible damages caused by third parties and that are not attributable to the Organizer.

8.3. The Organizer will not be responsible in the event of interruptions of the Services, delays, errors, malfunctions of the same and, in general, other inconveniences that have their origin in causes beyond the Organizer's control, and/or due to an action willful or negligent by the User and/or originates from Force Majeure or Act of God.

9. Validity of the contract

9.1. If any of the clauses of these Contract Conditions turns out to be invalid, null or unenforceable for any reason, said condition will be excluded and will not affect the validity or applicability of the rest of the conditions.

9.2 The Organizer reserves the right to make changes to these Conditions of Contract. The modifications will be applicable to the accreditations after their publication on the Website.

9.3 The Organizer reserves the right to decide on all those issues not regulated in these Contract Conditions and to add to these Contract Conditions the appropriate clauses to regulate such matters, which will be immediately applicable from their publication on the SPORTS SUMMIT website. The Organizer will notify these new

conditions to the accredited Users when it deems necessary in view of their incidence in their participation in the Event.

10. Applicable law and jurisdiction

The relations established between the User and SPORTS SUMMIT will be governed by Uruguayan legislation. The User and the Organizer, expressly waiving any other jurisdiction that may correspond to them, will submit any disputes and/or litigation to the jurisdiction of Uruguay.
